This agreement enrolls you in the New York Academy of Art tuition payment plan, which divides each semester's tuition and fees balance, after financial aid, into four installments. 2. Payment Plan Terms

Please read and acknowledge each of the following by checking the box.

I understand that a \$250 payment plan fee applies for each semester I use the plan, and that it is divided into my four installments.

I understand that payment is by credit card only. The Accounting Office will process my first installment and set up automatic credit card payments for the remaining installments, each charged to the card on file on its due date.

I understand that a 3.5% processing fee applies to each credit or debit card payment and is my responsibility.

I understand that a \$100 late fee applies to any installment not paid by its due date, and a \$50 fee applies to any returned or declined payment, and that a declined payment is subject to both, for a combined \$150.

I understand that the \$250 payment plan fee is non-refundable if I withdraw or drop, and that any tuition refund follows the Academy's refund policy.

I understand that an unpaid balance may result in administrative holds that affect my ability to register, receive my diploma, or access my records and transcripts.
